LATE CHANGES TO THE AGENDA

Mayor Added under Old Business item B. Poet Laureate Patricia Thomas and Item C. Executive Session CITIZEN COMMUNICATION

Patricia Thomas was signed up; the Mayor expressed to her she could speak during Old business since she was added to the agenda

OLD BUSINESS

A. C-Tran -Discussion - Appointment

Lisa Walters Mayor of Battle Ground was present to speak with the council. She expressed concern for the C-Tran appointment. Her goal is to come to some kind of agreement to allow Mr. Ganley to continue on the C-Tran board for one more year. She stated he was going to be chairman of the board and it was a big deal to have someone for North Clark County in that position. She stated she understood that Ganley being the representative for such a long time was part of the issue. She noted that bylaws for C-Tran are looked at every 4 years and that would be coming up in the near future. This may be the time to allow for changes in representation. Mayor Walters stated that all of North County needs to stick together. She asked that council member Gerhardt shadow Ganley for this year and they make decisions together.

Bill Ganley spoke of his tenure on the board and his decision making for the Town of Yacolt. He stated he didn't know where all the information about light rail came from but he was not for light rail, it had no benefit for Battle Ground and he suspected it didn't for Yacolt either. He stated he was a rapid bus transit person, it was his passion. He expressed his fight to keep bus service in Yacolt.

Mayor Carothers expressed his concern about communication being very limited from Mr. Ganley in the past. He read a portion of the C-Tran bylaws to Mr. Ganley about the voting process and communication. Mr. Ganley wasn't aware of the specific bylaw but expressed he was available for information at any time. Mayor Carothers stated that he needed to communicate more with the council not just himself. Mayor Carothers noted that in Battle Ground Council minutes that the City Council

appointed an alternate for the C-Tran board. He stated that Yacolt holds the alternate position with Council Member Rick Urias. There was discussion about C-Tran meeting minutes availability. Mayor Walters stated that Battle Ground could not have an alternate but their council member was going to shadow Mr. Ganley at the meetings. Mayor Carothers stated that there was no Inter local agreement for this position and there needed to be one in place. Clerk stated she had drafted one and given it to the Town attorney.

There was discussion on workshops and quarterly meeting between the Town of Yacolt and Battle Ground Mayor's and Council members. A motion was made to retain Bill Ganley as representative for Yacolt on the C-Tran board with Lewis Gerhardt as alternate shadowing Mr. Ganley for the next year. The Clerk or the Attorney will send over draft Interlocal agreement to Battle Ground Council for review. It was noted that there was to be more communication.

B. Poet Laureate Patricia Thomas

Patricia stated that Patrick Knowles was a good candidate for the position and she felt the council should appoint him. He would work with her and other poets to help get the program started. Council member Myers asked Mr. Knowles if he really wanted to take on this position, Mr. Knowles stated he did and he understood how kids feel trying to get started.
