Kathy Lattig spoke to the council about the wellness program that the staff members are engaging in. She noted the gratitude graffiti that was placed on the windows of town hall as part of the program and encouraged council members to read and participate.

OLD BUSINESS

A. C-Tran Update - David Ridenour- Town Attorney

Discussions continued on this subject matter. David Ridenour, town attorney and Mayor Carothers attended Ridgefield's council meeting. Ridgefield discussed Yacolt and La Center having a meeting on the matter. Ridgefield's discussion included the amount of revenue the city has and weighted population voting. The Ridgefield council had in their possession the agreement that was worked out between Yacolt and La Center. David Ridenour, town attorney and Mayor Carothers both addressed the Ridgefield's council holding nothing back. Yacolt and La Center reached a compromise but Ridgefield's counter proposal is to have a 4 year rotation giving them the C-Tran seat every other year and a straight voting agreement beginning in 2016 with Ridgefield holding the first seat which would then give them the seat when the next composition board review took place. Ridgefield is concerned about communication, Mayor Carothers pointed out that Yacolt is the only one communicating. Councilmember Myers stated the 3 year rotation agreement reached with La Center should be satisfactory, every other year for Ridgefield is an attempt to have the advantage and to try to get weighted voting. Yacolt is sticking to their guns, no alternating years for Ridgefield and continue with the agreement reached with La Center. Mayor Carothers was instructed by

the council to relay that information to David Ridenour, town attorney. If an agreement is not reached by the end of the year it is possible that the seat would become vacant.
