A. Repealer's Ordinances- David Ridenour

David Ridenour, town attorney, gave background history to the process that has been taking place as the town moves to a Municipal Code. He talked about inviting the council to view the book of Ordinances that was placed in share folder drop box. Herb Noble, Kim and Tom Glassett, the Councilmembers Mayor and Roger Foley engaged in conversation/discussion about the proposed tri-plex placement, surroundings, health department requirements and the need for multi-family homes in Yacolt. The council instructed staff to move forward in the process to amend Ordinance # 371 and review necessary information that may be restrictive.

I. Proposed Ordinance to Adopt Yacolt Municipal Code – David Ridenour

A. WA-UTV Allowance in Yacolt- Dennis Corn

Dennis Corn addressed the council on this issue. He explained the Dept. of Licensing laws that he had met and the need for the allowance. He provided the council with a letter of explanation. C. Chelatchie Prairie RR _ Douglas Auberg

Douglas Auberg, provided the council with drawings and map of the area where they will be building a prefabricated shop to house railroad cars for repairs. He apologized to the council for not coming to speak

to them sooner on the RR plans for commercial development. He talked about the process they went through to get funding for the project and the challenges they still faced.

D. Forest Practices Ordinance Draft - Clerk Treasurer

Cindy Marbut, clerk treasurer, gave background to the property known as Yacolt Crossing and how the town got involved in the need for an ordinance/ policy to address forest practices. She talked about there being no current policy and how the Town will be responsible for lifting a moratorium that has been assigned to the property known as Yacolt Crossings. She noted that the town attorney may not agree. David Ridenour, spoke to some language he had discovered that may make the Dept. of Natural Resources the lead agency. Cindy Marbut stated that all contacts she had spoken to would disagree. It was clear that this ordinance was not in final form for adoption and each party pointed out. The issue is to be brought back to a future meeting.

E. C-Tran Affirmation of Representative Bylaws -

David Ridenour, town attorney reviewed the Interlocal agreement details with the council and those present. There was much discussion on representation and who should or should not represent Yacolt in the next year. Councilmember Tester stated it would be difficult for her to commit now that she has a full time job that requires her to work night, Councilmember Wallway stated he could be an alternate but he too would find difficulty in the commitment. Councilmember Tester noted that the current representative does a great job for Yacolt and the other municipalities he represents. There are some risks in having someone else take our turn as David Ridenour, town attorney pointed out. No definite decision has to be made until December 31, 2016. Councilmember Tester will discuss with the other municipalities what their thoughts are report back to the council at the next meeting.

F. Animal Control - Coming County Proposal to Increase Rates - David Ridenour

David Ridenour, town attorney talked about the Town's Interlocal agreement and the desire of Paul Scarpelli the representative for Clark County Animal Control to increase rates. The basis of the rates increases are due to no increases in the past 13 years and the short staffing that is occurring. He gave examples of the possible increased costs.

The town website has information that is important, information is key.

Public Works, Pete Roberts Comments:

Devin Jackson is going to help find the markers for the right of way with the Becker property.

Clerk Treasurer, Cindy Marbut Comments:

The town will have an audit from AWC/RMSA on Tuesday, she reviewed the types of things the organization will be looking for and felt confident in the outcome. She talked about website designs and directed council member's to look at one that she felt was the best update for the Town, it is user friendly and it mobile friendly. She then discussed programs that have been looked at for the agenda process and the improvements to transparency could be realized with this program type. She talked about the ease of the agenda process, paperless, savings to the town, reduction in supplies costs and even public records requests. She would be bringing a proposal to the budget work session next week. She reminder staff of the work session next week on budget expenses. She explained the green lights at town hall and the representation of Veterans. The newsletter is complete and copies are available at town hall and will be emailed out Tuesday. She explained the reasoning for not doing mailings any further due to the costs associated with it and returned mailings.
