## ORDINANCE #338

AN ORDINANCE AMENDING SECTION 4, ITEM C,,GAMBLING TAX ORDINANCE #303 COMPUTING TAX RATE FROM 3% to 5%.

WHEREAS: The Town Council of Yacolt, WAshington are in regular session this 5 day of October, 1992: and

WHEREAS: All members have had notice of time, place, and purpose of said meeting: and

NOW THEREFORE: BE IT ORDAINED BY THE TOWN COUNCIL OF YACOLT, WASHINGTON.

SECTION 1; Punch Board or Pull-tab: any Punch Board or Pull-Tab, a tax computed at the rate of five percent (5%) of the gross receipts from the conduct of such activity, provided, however, that no tax shall be imposed under the authority of this Ordinance on Punch Board or Pull-tab when such activities are conducted by any bonafide charitable or non-profit organization as defined in RCW 9.46.020(3).

SECTION 11: Section 4, item C, of Ordinance #303, is hereby amended to read in accordance with this amendatory Ordinance. The remaining terms and conditions of Ordinance #303 shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall take effect on  $\_\_$  day of January ,1993, upon adoption and publication according to law.
