WHEREAS, the Town of Yacolt of Clark County has met and considered (Name of the taxing district)

WHEREAS, the districts actual levy amount from the previous year was \$ 133,444.38 (Previous year's levy amount) ; and,						
WHEREAS, the population of this district is more than or (Check one) less than 10,000; and now, therefore,						
BE IT RESOLVED by the governing body of the taxing district that an increase in the regular property tax levy						
is hereby authorized for the levy to be collected in the $\frac{2014}{\text{(Year of collection)}}$ tax year.						
The dollar amount of the increase ever the actual levy amount from the previous year shall be \$ 25,721.62						
which is a percentage increase of 19.27516 % from the previous year. This increase is exclusive of (Percentage increase)						
additional revenue resulting from new construction, improvements to property, newly constructed wind turbines, any increase in the value of state assessed property, any annexations that have occurred and refunds made.
