

ORDINANCE #489

REPEALING ORDINANCE #476 AND ALLOWING AN ORDINANCE AMENDING SECTION 3, ITEM (A)(B)(C) UTILITY TAX ORDINANCE #231 OF THE TOWN OF YACOLT, WASHINGTON; INCREASING UTILITY TAX FROM 5.3% TO 6%

WHEREAS: The Town Council of the Town of Yacolt, Washington is in regular session this 23rd day of January 2012; and

WHEREAS: All members of the Town of Yacolt have had notice of time, place and purpose of said meeting; and

WHEREAS: The Town Council desires to reinstate a repealed utility tax set forth in Ordinance # 470 by Repealing Ordinance # 476 and allowing Ordinance # 231 to be amended; and


NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Yacolt, Washington, as follows:

- SECTION 1 : (a), (b), (c) Upon any telephone, electric, energy or gas company there shall be levied a tax equal to 6% of the total gross operating revenues, excluding revenues from intrastate toll, derived from the operation of such businesses within the limits of Yacolt, Washington. Gross operating revenues for this purpose shall not include charges which are passed on the subscribers by a telephone company pursuant to tariffs required by regulatory order to compensate for the cost to the company of the tax imposed by this Ordinance
- SECTION 2: Section 3. Item (A)(B)(C), of Ordinance #231, is hereby amended, with this amendatory Ordinance. Ordinance # 476 is hereby repealed. All remaining terms and conditions of Ordinance #231 shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall take effect on the 29th of January upon adoption and publication according to law

Town Of Yacolt –Summary of Ordinance # 489

The Town Council of the Town of Yacolt adopted Ordinance # 489 at its regularly scheduled Town Council Meeting on January 23rd, 2012. The content of the Ordinance is summarized in its title as follows:

AN ORDINANCE OF THE TOWN OF YACOLT REPEALING ORDINANCE #470 AND AMENDING ORDINANCE #231 TO INCREASE ALL UTILITY TAXES FROM 5.3% TO 6% WHICH IS ALLOWED BY LAW AND ESTABLISHING AN EFFECTIVE DATE. The effective date of the Ordinance is January 31, 2012.
