WHEREAS, it is desire and intention of the Town of Yacolt to amend the annual budget for the year 2015 to reflect the revenue earned in the amount of \$2036.05 and the investment expenditures of \$115,332.54 in accordance with the authority given to the Town of Yacolt under RCW 35.A.33.120(4);



MINISTERIAL CHANGES TO ORDINANCE #536

A meeting date of "December 15th" was changed to December 15th.


The following sentence was changed to eliminate the "to" that was crossed out in the original Ordinance:

A change was also made to correct spacing in the final "Whereas" clause.






