

ORDINANCE # 558

AN ORDINANCE AMENDING ORDINANCE # 537 THE ANNUAL BUDGET OF THE TOWN OF YACOLT WASHINGTON FOR THE YEAR 2016. AMENDING THE GENERAL FUND #001 AND THE STREET FUND # 101 BUDGETS TO REFLECT ANITICIPATED REVENUE AND EXPENSE FOR YEAR ENDING 2016 AND AUTHORIZING A TRANSFER OF \$5,000 FROM FUND # 001 GENERAL FUND TO FUND # 101 STREET FUND.

**WHEREAS**, The Town Council of Yacolt, Washington, is in regular session this 19<sup>th</sup> day of December, 2016 and;

**WHEREAS**, all members of the Town Council of the Town of Yacolt, Washington have had notice of time, place and purpose of said meeting, and;

**WHEREAS**, The annual budget of the Town of Yacolt for the year 2016 was fixed and determined by Ordinance #537 which was duly adopted by the Town Council of Yacolt at a regularly scheduled meeting thereof on December 7, 2015, and;

**WHEREAS**, the said annual budget for the year 2016 set for the total budget that did not include increased building, payment for professional services exceeding the budget amount and Transportation Improvement Grant funding expenses, and;

**WHEREAS**, the said annual budget for the year 2016 set for the total budget in Fund # 101 Street Fund which exceeded the anticipated expenses as budgeted, and;

**WHEREAS**, it is the desire and intention of the Town Council of the Town of Yacolt, Washington to amend the annual budget for the year 2016 to reflect the anticipated revenue and expenditures for year ending 2016 for the funds #001 General Fund and #101 Street Fund and authorize a transfer of \$5000 from the General Fund #001 to the Street Fund # 101, and;

**WHEREAS**, the authority is given to the Town Council of Yacolt, Washington under state statute and RCW 35.33.121 and;

**NOW, THEREFORE, THE TOWN COUNCIL OF YACOLT, WASHINGTON, do ordain as follows:**

**Section 1 Fund Transfer:** The Town Council of the Town of Yacolt, does hereby authorize the transfer of funds from Fund # 001 General Fund to Fund # 101 Street Fund in the amount of \$5000.00.

**Section 2 Budget Amendment:** The Town Council of the Town of Yacolt, does hereby authorize the amendment to the annual budget for year 2016 to reflect the anticipated revenue and expense for year ending 2016 as follows:

**Section 3 – Severability:** If any section, subsection, paragraph or sentence, clause or phrase of this Ordinance is declared unconstitutional or invalid for any reason by a court of competent jurisdiction, or its application to any person or circumstances is held invalid, the remaining portion of this Ordinance shall remain in full force and effect, and the application of the provision to the other persons or circumstances shall not be affected.

**Section 4- Effective Date:** This Ordinance shall take effect immediately upon adoption and publication of the following summary according to law.




