AN ORDINANCE OF THE TOWN OF YACOLT, WASHINGTON, REPEALING OBSOLETE ORDINANCES #31, #32, #33, #49, #67, #80, #89, #98, #109, #125, #130, #141, #181, #206, #225, #240, #241, #252, #270, #282, #314, #363, #372, #373, #374, #386, #392 AND #405, ALL PERTAINING TO THE TOWN OF YACOLT'S WATER DEPARTMENT; AND PROVIDING FOR AN EFFECTIVE DATE

Whereas, the Town Council of the Town of Yacolt has deemed it advisable and necessary to codify the Town's Ordinances, and is therefore preparing to adopt a Yacolt Municipal Code;

Whereas, the Town of Yacolt has identified a number of Ordinances which are no longer valid due to court decisions or changes in circumstances, or which have been substantially repealed by the enactment of later ordinances, or which have been pre-empted by State law;

Whereas, in preparing Yacolt's Municipal Code, it is advisable and necessary to exclude those Ordinances which are not or should not any longer be considered effective; and,

Whereas, the Town Council of the Town of Yacolt is in regular session this 5th day of December, 2016, and all members of the Town Council have had notice of the time, place, and purpose of said meeting:

NOW THEREFORE, be it Ordained by the Town Council of the Town of Yacolt, Washington:

Section 1 - Repealer: The following Ordinances are hereby repealed:

- (A). Ordinance #31: Ordinance #31 of the Town of Yacolt, adopted May 1, 1911, entitled "An Ordinance to Regulate the Management of the Water Works of the Town of Yacolt, Specify the Price to be Charged, Designate the Collection of Water Rents and the Proper Committee of the Council to Handle the Business and Other Particulars Regarding the Government of the Water System of Yacolt, Washington" is hereby repealed.
- (B). Ordinance #32: Ordinance #32 of the Town of Yacolt, adopted May 1, 1911, entitled "An Ordinance to Prevent the Waste of Water by Householders and Others in the Town of Yacolt" is hereby repealed.

<u>Section 2 - Effect of Repeal</u>: The repeal of an ordinance shall not repeal the repealing clause of such ordinance or revive any ordinance which has been repealed thereby.

<u>Section 3 – Severability</u>: If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance is declared unconstitutional or invalid for any reason by a court of competent jurisdiction, or its application to any Person or circumstances is held invalid, the remaining portion of this Ordinance shall remain in full force and effect, and the application of the provision to other Persons or circumstances shall not be affected.

<u>Section 4 - Effective Date</u>: This Ordinance shall take effect immediately upon adoption and publication of the following summary, according to law.
