## **ORDINANCE #8**

AN ORDINANCE PROVIDING FOR THE RETURN AND CANVASS OF THE VOTES AT THE CITY ELECTIONS AND THE ISSUING OF ELECTION CERTIFICATES.

Be it ordained by the Council of the town of Yacolt:

Section 1: It shall be the duty of the election officers in the several wards of the town at any general or special election to return and file with the town clerk as soon as the votes are counted, the election returns of each ward, and thereafter on the first Monday following the election the council shall convene and publicly canvass the results and shall issue certificates of election to each person elected by a plurality of votes.

Section 2: When two or more persons have received an equal and highest number of votes for any of the offices voted for, the town council shall thereafter at its first regular meeting, decide by lot between the parties which shall be elected, and issue a certificate of election to the successful candidate.

Section 3: If the town council from any cause, fail to meet on the first Monday after election, the Mayor shall call a special meeting of the council within five days thereafter. If the mayor fail to call such special meeting within five days, any four councilmen may call it. At such special meeting all elections appointments or other business may be transacted that could have been done on the first Monday after the election.
