

An Ordinance to amend ordinance No 15 of the Town of Yacolt in regard to Nuisances and providing for an additional method of enforcement thereof and prescribing duties of the Town Health Officer.

Be it Ordained by the Council of the Town of Yacolt:

Section I That Ordinance No. 15 of the Town of Yacolt, entitled "An Ordinance to define nuisances, to provide for the abatement thereof, and punishment of those who allow or maintain them" is hereby amended by adding thereto a new section to be known as Section VIII thereof, as follows:

Section VIII It shall be the duty of the Town Health Officer to enforce the provisions of this Ordinance and he shall be given access to all premises within the town limits for that purpose, whenever any nuisances as defined by this ordinance shall come to his attention, he shall immediately order the person responsible therefor to abate the same. If such person shall fail or refuse to do so, the Health Officer shall at once make complaint thereon to the police justice, who shall proceed as

required by law, but, provided that the method of enforcement provided in this section shall not be exclusive, nor shall any notice to violators of this Ordinance be a prerequisite to Conviction.

The judgment of the health officer as to whether any nuisance described in this ordinance is a menace to the health of any resident or inhabitant of the town shall be final and conclusive for all purposes of this ordinance.

This amendment shall be in full force and effect five days after its passage, approval by the mayor and publication according to law.
