Ordinance No 62

An Ordinance amending the fourth section of Ordinance No. 45, entitled "An Ordinance empowering the Mayor of the Town of Yakast to appoint an Attorney, Poundmaster, a Superintendent of streets, Civil Engineer, Police officers, a Health Officer, marshal and Clerk; to report such appointments of said officers to the Town Council; to fix the salaries and compensations of such officers as are to receive Salaries or Compensations; to provide for bonds for all or any of said appointed or elective officers; and to provide any other regulations of all or any of the said officers as may be deemed necessary by the Mayor and Council, and to repeal Ordinance No. 30, passed by the Town Council March 6, 1911."

Be it ordained by the Council of the Town of Yakast, Washington as follows:

That the fourth section of Ordinance No. 45, entitled "An Ordinance empowering the Mayor of the Town of Yakast to appoint an Attorney, Poundmaster, a Superintendent of Streets, Civil Engineer, Police Justice, Police Officers, a Health

Officer, Marshall and Clerk); to report such appointments of said Officers to the Town Council; to fix the salaries and Compensations of such Officers as are to receive salaries or compensations; to provide for bonds for all or any of said appointed or election officers and to provide any other regulations of all or any of the said Officers, as may be deemed necessary by the Mayor and Council, and to repeal Ordinance No. 3, passed by the Town Council March 6, 1911, be amended and the same is hereby amended to read as follows:

Fourth: The following mentioned officers shall receive for their services the following named amounts, to-wit:

The clerk the sum of \$10.00 per month
 The Marshall the sum of \$20.00 per month, during the months of October, November, December, January and February of each year, of which \$15.00 shall be paid out of the Current Expense Fund and \$5.00 out of the Water Fund; and 25.00 per month during the months of March, April, May, June, July, August and September, of which \$20.00 shall be paid out of the Current Expense Fund and \$5.00 out of the Water Fund.

The Attorney the sum of \$ — per month

The Civil Engineer the sum of \$ — per

month;

The Health Officer the sum of \$ — per month

The Superintendent of streets the sum of \$ — per month

The Police Justice the sum of \$ 2.00 per trial.

This Ordinance shall be in full force and effect from and after its passage by the Council and publication according to law.
