Ordinance #84.

An ordinance closing and vacating that portion of Wilson Avenue in the Town of Yacolt, from the East line of Hubbard Street to the East line of M<sup>e</sup>Donalds Addition in said town.

Be it Ordained by the Council of the Town of Yacolt:

That pursuant to a petition heretofore filed containing the names of all of the owners of property abutting upon that portion of Wilson Avenue from the East Line of Hubbard Street to the East Line of M<sup>e</sup>Donalds Addition, a Resolution was adopted fixing Monday, April 15, 1935, at 8:00 o'clock P. M. as the time for hearing said petition; that notice thereof was given in the manner and for the time required by law, and it appearing at said hearing that said street should be closed and vacated,

Ordinance # 85. Repealed

Ord # 45

An Ordinance amending the fourth section of Ordinance No. 45, entitled: "An Ordinance empowering the Mayor of the Town of Yacolt, Washington, to appoint an Attorney, Poundmaster, a Supt. of Streets, Civil Engineer, Police Justice, Police Officers, a Health Officer, Marshall and Clerk; to report such appointments of said officers to the Town Council; to fix the salaries or compensations; to provide for bonds for all or any of said appointive or elective officers and to provide any other regulations of all or any of the said officers as may be deemed necessary by the Mayor and Council," as amended by Ordinances No. 62, 66 and 79 and repealing all ordinances or parts of ordinances in conflict herewith.

Be It Ordained by the Council of the Town of Yacolt, Washington, as follows:

Section I. That the fourth section of Ordinance # 45 entitled "An Ordinance empowering the Mayor of the Town of Yacolt, Washington, to appoint an Attorney, Poundmaster, a Supt. of Streets, Civil Engineer, Police Justice, Police Officers, a Health Officer, Marshall and Clerk; to report such appointments of said officers to the Town Council; to fix the salaries or compensations; to provide for bonds for all or any of said appointive or elective officers and to provide any other regulations of all or any of the said officers as may be deemed necessary by the Mayor and Council," as amended by Ordinances Nos. 62, 66 and 79 be amended to read as follows:

"Sec. 4: The following mentioned officers shall receive for their services the following named amounts, to-wit:

- The Clerk the sum of \$10.00 per month.
- The Marshall the sum of \$10.00 per month.
- The Attorney the sum of \$ — per month.
- The Health Officer the sum of \$ — per month.
