

AN ORDINANCE providing for the filing of declarations of candidacy and the paying of a filing fee therefor as the method for mominating candidates for the annual municipal general election, providing for the required filing dates, and repealing ordinance No. 107, all other ordinances or parts thereof in conflict herewith.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF YACOLT, under and by virtue of the provisions of Chapter 254, Laws of 1951 and Chapter 161, Laws of 1949, as amended by Chapters 101, and 257, Laws of 1951 of the state of Washington, as follows:

Section 1. Filing of Declaration and Affidavit of Candidacy.

Required Filing Dates. Anyone desiring to become a candidate for any elective office for the Town of Yacolt, Washington shall file a declaration of candidacy and an affidavit that he is not a "subversive person" as defined by Section 1 (e), Chapter 254, Laws of 1951 of the state of Washington and file the same with the Town Clerk not more than sixty (60) nor less than forty-five (45) days prior to the Town general election.

Section 2. Filing Fee. Each declaration and affidavit of candidacy shall be accompanied by a filing fee equal to 1 per cent of the annual salary of the office being filed for; Provided, however, that no filing fee is required in the event that the office sought is without compensation.

Section 3. Withdrawal of Candidacy. Any person shall have the right to decline his candidacy at least twenty (20) days prior to the Town general election by notifying in writing the officer who issues the certificate of candidacy.

Section 4. Duties of the Town Clerk. It shall be the duty of the Town Clerk to provide places for holding the municipal general election; to appoint the precinct election officers; to provide for their conpensation; to provide ballot boxes and ballot or voting machines at the polling places; and to publish and post notices of calling Town general elections in the manner provided by Section 7, Chapter 101, Laws of 1951 of the state of Washington.


The Town Clerk, whenever requested by the school district officers shall conduct the school district elections in conjunction with the town municipal general election, Provided, the results of each school district election shall be canvassed by the school district officers, and that school districts shall be held liable for their proportionate share of the costs of such election.

Section 5. Persons Precluded From Filing A Declaration Of Candidacy For More Than One Office. No person may file a declaration of candidacy for more than one office.

Section 6. Partial Invalidity. If any portion of this ordinance shall be adjudged invalid, such invalidity shall not affect the portions which are not adjudged invalid.

Section 7. Conflicting Ordinances Repealed. Ordinance No. 107 and all ordinances or parts of ofdinances in conflict with, or in derogation of, this ordinance or any part of this ordinance, be and the same are hereby repealed insofar as the same are in conflict with, or in derogation of, this ordinance, or any part hereof.

This Ordinance shall become effective after it's passage by the Town Council and posting as according to law.



An Ordinance relating to the Current Expense Fund: declaring an emergency and appropriating money by reason thereof:

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF YACOLT, WASHINGTON as follows:

Section 1

Due to the installation of new street lights around the newly annexed property of the Town of Yacolt and not enough money having been budgeted for the payment of street lighting, an emergency is found to exist and an emergency is hereby declared to exist:

Section 2

The amount to meet this emergency is \$56.70 and that part of the budget in the Current Expense Fund pertaining to street lighting is hereby increased \$56.70.

Section 3

This Ordinance shall become effective after its passage by the Town Council and posting as according to law.
