

ORDINANCE NO. 126

An Ordinance relating to the Current Expense Fund: declaring an emergency and appropriating money by reason thereof:

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF YACOLT, WASHINGTON.

Section 1

Due to the great amount of fire extinguisher charges used by the Fire Department and not enough money having been budgeted in the Fire Department Fund, an emergency is found to exist and an emergency is hereby declared to exist.

Section 2

The amount to meet this emergency is \$62.86 and that part of the budget in the Current Expense Fund pertaining to the Fire Department is hereby increased \$62.86.

Section 3

This Ordinance shall be in effect from and after its passage by the Town Council and five days after posting thereof as provided by law.

ORDINANCE NO. 127

An Ordinance relating to the Street Maintenance, purchase of equipment for this maintenance, and the transfer of funds to purchase said equipment.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF YACOLT, WASHINGTON.

SECTION 1.

The present grader, used by the Street Department, being in such poor condition as to need extensive repairs, is regarded by the Council as being too worn out to merit further expenditures upon it.

SECTION 2.

An opportunity to purchase a better grader from the Clark County Road Department has recently been presented to and recommended by the Council.

SECTION 3.

The estimated cost of this grader is \$2,500.00. Since the funds available to the Street Department are of such an amount that, if the cost of the grader were paid from these funds all the planned street improvements for this year would have to be canceled, the Council recommended that the amount of \$2,500.00 be borrowed from the water fund.

SECTION 4.

For the reasons stated in the above sections, the sum of \$2,500.00 is hereby transferred from the water fund to the street fund.

SECTION 5.

This Ordinance shall be in effect from and after its passage by the Town Council and five days after posting thereof as provided by law.
