### Privacy and Disclaimer line

The Town of Yacolt website <u>www.townofyacolt.com</u> (or any domain owned by the Town of Yacolt) will remain the Town's primary means of internet communication.

Any individual accessing, browsing and using a Town of Yacolt Social Media site accepts without limitation or qualification, of the Town of Yacolt's Social Media Policies (hereafter "Policies") These terms and conditions apply only to the Social Media sites, defined here as third party hosted online technologies that facilitate social interaction and dialogue, such as Facebook, (Twitter and You Tube) that are managed by the Town of Yacolt.

The Town of Yacolt maintains the right to modify these Policies without notice. Any modifications is effective immediately upon posting the modification on the Social Media Policy Page unless otherwise stated. Continued use of the Town of Yacolt Social Media site following the posting of the any modifications signifies acceptance of such modification.

## **Posting Policy**

Although posts and comments are encouraged on the Town of Yacolt Social Media sites that allow posts, these sites are limited public forums and are moderated by a designated media monitor which could include town staff or other officials. All posted content (comments, photos, links, etc. must be related to discussion of Town programs, services, projects, issues, events and activities.

Posts will be reviewed by an assigned media monitor each day for compliance before allowed to be posted on the Town of Yacolt's Social Media sites.

If a potential post is determined by the assigned media monitor or by other designated monitor(s) to be in violation of this policy or any sections prohibiting the post as outlined in this policy, the post will not be included on the Town's Social Media site.

The first offense of an individual(s) for violation of the town's *Social Media Policy* will result in a warning and any further violation(s) will result in the immediate blocking of that individual(s) from sending any content to the Town of Yacolt Social Media sites.

#### The following are prohibited on Town of Yacolt Social Media sites:

Comments not topically related to Town programs, services, projects, issues, events and activities, or the particular post being commented upon.

Posts and comments that promote or advertise commercial services, entities or products; except as determined by the moderator to be essential to economic development.

Political statements, including comments that endorse or oppose political candidates or ballot propositions, are prohibited under state law (RCW 42.52.180).

Religious statements, including comments that endorse or oppose any type of religious opinions or activities.

Posts and comments that promote, foster or perpetuate discrimination on the bases of creed, color, age, religion, gender, marital status, status with regard to public assistance, national origin, physical or mental disability or sexual

orientation.

Obscene or sexual content or links to obscene or sexual content, illegal activity or encouragement of illegal activity.

Information that may tend to compromise the safety or security of the public or public systems. Content that violates a legal ownership interest of any other party.

The Town of Yacolt reserves the right to remove posted content that does not comply with these Policies. All posts and comments uploaded to the Town of Yacolt Social Media sites that allow posts will be periodically reviewed. All posts and comments are public records and subject to public disclosure under the Public Records Act.

Communications made through Town of Yacolt Social Media sites does in no way constitutes a legal or official notice or comment to the Town of Yacolt (For example, a post comment that asks for public records will not be considered a request under RCW 42.56).
