A RESOLUTION OF THE TOWN OF YACOLT, WASHINGTON, AUTHORIZING A ONE PERCENT (1%) INCREASE IN THE REGULAR PROPERTY TAX LEVY.

WHEREAS, the Town Council of Yacolt, Washington has properly given notice of the meeting held the 15th day of November, 2010, to consider the Town of Yacolt's current expense budget for the 2011 calendar year, pursuant to RCW 84.55.120 and;

WHEREAS, the Town Council of the town of Yacolt, after hearing and after duly considering all relevant evidence and testimony presented, determined that the Town of Yacolt requires a regular levy in the amount of \$219,394.67 which includes an increase in property tax revenue from the previous year, in order to discharge the expected expenses and obligations of the district and in its best interest;


NOW THEREFORE, BE IT RESOLVED by Town Council of the Town of Yacolt, that an increase in the regular property tax levy is hereby authorized for the 2011 levy in the amount of \$21,532.67 which is a percentage increase of 1% from the previous year.

This increase is exclusive of additional revenue resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property, and any additional amounts resulting from any annexations that have occurred and refunds made.

WHEREAS, the Town of Yacolt of Clark County has met and considered its budget for the calendar year 2011; and,

WHEREAS, the districts actual levy amount from the previous year was \$ 197,862.00; and,

WHEREAS, the population of this district is less than 10,000; and now, therefore,

BE IT RESOLVED by the governing body of the taxing district that an increase in the regular property tax levy is hereby authorized for the levy to be collected in the 2011 tax year.

The dollar amount of the increase over the actual levy amount from the previous year shall be \$ 21,532.67 which is a percentage increase of 11% from the previous year. This increase is exclusive of additional revenue resulting from new construction, improvements to property, newly constructed wind turbines, any increase in the value of state assessed property, any annexations that have occurred and refunds made.
