WHEREAS, the Town Council of the town of Yacolt, after hearing and after duly considering all relevant evidence and testimony presented, determined that the Town of Yacolt requires a regular levy in the amount of \$219,394.67 which includes an increase in property tax revenue from the previous year, in order to discharge the expected expenses and obligations of the district and in its best interest:

NOW THEREFORE, BE IT RESOLVED by Town Council of the Town of Yacolt, that an increase in the regular property tax levy is hereby authorized for the 2011 levy in the amount of \$21,532.67 which is a percentage increase of 1% from the previous year.

This increase is exclusive of additional revenue resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property, and any additional amounts resulting from any annexations that have occurred and refunds made.
