

RESOLUTION #439

A RESOLUTION OF THE TOWN OF YACOLT, WASHINGTON, AUTHORIZING A ONE PERCENT (1%) INCREASE IN THE EMERGENCY MEDICAL SERVICES PROPERTY TAX LEVY.


WHEREAS, the Town Council of Yacolt, Washington has properly given notice of the meeting held the 15<sup>th</sup> day of November, 2010, to consider the Town of Yacolt's current expense budget for the 2011 calendar year, pursuant to RCW 84.55.120 and;

BE IT RESOLVED by the Town Council of the Town of Yacolt that an increase in the emergency medical services property tax levy is hereby authorized for the 2011 levy in the amount of \$413.07 which is a percentage increase of 1% from the previous year.


This increase is exclusive of additional revenue resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property, and any additional amounts resulting from any annexations that have occurred and refunds made.

A CERTIFIED BUDGET request or estimate is filed with the County Legislative Authority, separate from the resolution. As required by RCW 84.52.020, that filing certifies the total amount to be levied by the emergency medical services property tax levy. The form for this purpose is titled "Levy Certification" and is available through the Assessor's Office. Certification is made in a manner prescribed by the County Legislative Authority.

WHEREAS, the Town of Yacolt of EMS District #1 Town of Yacolt has met and considered
