NOW THEREFORE, IT IS HEREBY ORDAINED BY THE TOWN COUNCIL OF YACOLT, WASHINGTON, AS FOLLOWS:

Section 1. From the effective date of this Ordinance, the installation fee for installing water meters and checking valves shall increase as follows:

3/4 " meter	\$350.00 installation
1" meter	\$425.00 installation
1 1/2" meter	\$250.00 plus time and materials - <i>delete</i>
1 1/2" meter	\$1250.00 plus time and materials - <i>del</i>
2" meter	\$1250.00 plus time and materials

Any larger than 2" meters should have it's own charge for installation and should be handled by contract with the town.
