An Ordinance regulating livestock at large, dairies and cow pens or staked out or stables housing same, or persons riding or leading horses on town or private property in the corporate limits of the Town of Yacolt, and providing a penalty for the violation thereof.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF YACOLT, WASHINGTON:

Section 1. It shall be unlawful for any person, firm, or corporation to have, build or maintain any cow pens or cow barns, or have or maintain any cow staked out on leash within the corporate limits of the Town of Yacolt, or to maintain any kind of a place where any kind of cattle, horses, mules, burros, sheep, goats or any fowl whether domesticated or not, or any kine of livestock are kept without first securing written permisssion from the Town Coundcil of the Town of Yacolt, Washington.

Section 2. That any person or persons, firm or corporation in the business of keeping cows, horses, mules, burros, sheep, goats or any fowl wh whether domesticated or not or any other livestock within Five-hundred (500) Feet of any residence in the Town of Yacolt shall upon written notice from the said Town Council or Clerk thereof within thirty days proceed to move same from the restricted area.

Section 3. Any person or persons, firm or corporations violating the terms of any part of this ordinance shall be deemed guilty of a misdemeanor and upon conviction shall be fined in the sum of not less than Twenty-Five (\$25.00) Dollars nor more than One Hundred (\$100.00) Dollars, and if said stock is not removed and said corrals, pens or barns are not removed from the restricted area, the said barns or pens or whatever may be in question pertaining to same shall be adjudged a nuisance and abatement proceedings institued.

Section 4. Any person or persons, firm or corporations permitting their livestock which include horses, cows, mules, burrow, sheep, goasts, or any fowl of any kind whether domesticated or not, to be at large within the corporate limits of the Town of Yacolt, Washington whether their residence be outside the limits of the Town of Yacolt or not, will be deemed guiltyof a misdemeanor and upon conviction thereof shall be fined in the sum of not less than Twenty-five (\$25.00) Dollars nor more than One Hundred (\$100.00) Dollars for each offense thereof.

Section 5. It shall be unlawful for any person or persons, firm or corporations to drive cattle or horses or any other livestock as in a herd through the corporated limits of the Town of Yacolt, Washington unless first obtaining a permit in writing from the town Marshal or town Council assuring the Town of Yacolt of any damages to town property during the course of said adrive of livestock and that the owner or owners, person or persons obtaining said permit will pay to the Town of Yacolt all damages done, at the discration of the Town Council as to the extent of damage therein,

Section 6. It shall be unlawful for any person or persons, firm or corporations to permit or allow the leading or riding of a horse on town property such as parks, parkways, sidewalks or lawns or using any part thereof for a bridle path, this includes all livestock at radom.

Section 7. Real of conflicting ordiances. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 8. This ordinance shall be in full force and effect after its passage by the Council, its approval by the Mayor and its publication according to law.
