

ORDINANCE #393

AN ORDINANCE AMENDING ORDINANCE #382, THE ANNUAL BUDGET OF THE TOWN OF YACOLT, WASHINGTON FOR THE YEAR 1999 TO REFLECT ACTUAL BEGINNING FUND BALANCES AND ADDITIONAL REVENUES.

WHEREAS: The Town Council of Yacolt, Washington, is in regular session this 20th day of March, 2000; and

WHEREAS: All members of the Town Council have had notice of time, place, and purpose of said meeting; and

WHEREAS: The annual budget of the Town of Yacolt for the year 1999 was fixed and determined by Ordinance #382 which was duly adopted by the Town Council of Yacolt at a regular meeting thereof on December 21, 1998; and

WHEREAS: The said annual budget for the year 1999 set forth a total for expenditures and revenues of \$592,606, the amount being based upon anticipated revenues which would be available to the Town during the calendar year; and

WHEREAS: Certain fund revenues will have more revenues than originally anticipated; and

WHEREAS: It is the desire and intention of the Town of Yacolt to amend the annual budget for the year 1999 to reflect total expenditures of \$484,810 and revenues of \$484,665 in accordance with the authority given to the Town of Yacolt under RCW 35.A.33.120(4);

NOW, THEREFORE, THE TOWN COUNCIL OF THE TOWN OF YACOLT, WASHINGTON DOES ORDAIN AS FOLLOWS:
