

ORDINANCE #417

AN ORDINANCE AMENDING ORDINANCE #407, THE ANNUAL BUDGET OF THE TOWN OF YACOLT, WASHINGTON FOR THE YEAR 2001 TO REFLECT ADDITIONAL REVENUES.

WHEREAS: The Town Council of Yacolt, Washington, is in regular session this 17<sup>th</sup> day of December, 2001; and

WHEREAS: All members of the Town Council have had notice of time, place, and purpose of said meeting; and

WHEREAS: The annual budget of the Town of Yacolt for the year 2001 was fixed and determined by Ordinance #407 which was duly adopted by the Town Council of Yacolt at a regular meeting thereof on December 18, 2000; and

WHEREAS: The said annual budget for the year 2001 set forth a total for expenditures and revenues of \$1,267,473, the amount being based upon anticipated revenues which would be available to the Town during the calendar year; and

WHEREAS: Certain funds will have more revenues than originally anticipated; and

WHEREAS: It is the desire and intention of the Town of Yacolt to amend the annual budget for the year 2001 to reflect total expenditures of \$1,591,376 and revenues of \$1,591,376 in accordance with the authority given to the Town of Yacolt under RCW 35.A.33.120(4);

NOW, THEREFORE, THE TOWN COUNCIL OF THE TOWN OF YACOLT, WASHINGTON DOES ORDAIN AS FOLLOWS:
