Ordinance #507

AN ORDINANCE AMENDING SECTION 3, ITEM (B) AND (C) UTILITY TAX ORDINANCE #231 FOR THE TOWN OF YACOLT, WASHINGTON; INCREASING ALL UTILITY TAX FROM 5.3% TO 6%

WHEREAS: The Town Council of the Town of Yacolt, Washington is in regular session this 22nd day of January 2013; and

WHEREAS: All members of the Town of Yacolt have had notice of time, place and purpose of said meeting; and

WHEREAS: The Town Council desires to amend Ordinance #231; and

WHEREAS: Ordinance #489 had previously increased utility tax to 6% on telephone tax; and

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Yacolt, Washington, as follows:

• SECTION 3, ITEM (B) There is hereby levied a tax on the sale, delivery or distribution of electricity and electrical energy and for the privilege of carrying on said business, such tax to be equal to 6% of the total gross operating revenue derived from sales of such electricity to ultimate users within the Town of Yacolt, Washington, provided however; that there shall not be any tax levied for the installation charges of electrical units.

•SECTION 3, ITEM (C) There is hereby levied a tax on the sale of natural, manufactured or mixed gas for residential, commercial or industrial consumption and for the privilege of carrying on said business, such tax to be equal to 6% of gross operating revenues from sales of natural, manufactured or mixed gas within the limits of the town of Yacolt, Washington.

EFFECTIVE DATE: This ordinance shall take effect on the 22^{nd} day of January upon adoption and publication according to law.
